OBJECTIVES:

The sexuality of a society serves as an avenue of approach to its social history. In this course about sex in ancient Greece and Rome, we will focus on many sexual issues that still trouble and energize our own society: women's rights, rape, prostitution, marriage, childbirth, homosexuality, and sexual awakening. Through the exploration of these topics from a feminist perspective, we will develop a picture of the ancient views on women, on "alternate" lifestyles, on laws regulating sex and sexual crime, and on human desire, which is itself timeless and ageless. The readings, culled from both primary sources and modern scholarship, will be supplemented throughout the semester by visual presentations of relevant art and architecture.
